AN EXPERIENCED PROSECUTOR COMMITTED TO BUILDING COMMUNITY

- Born in Boston, the daughter of an Irish-American father and a West Indian mother who are retired after a combined 60 years of service in Boston Public Schools
- A student activist at UMass. Amherst, she initiated a Title IX lawsuit to force the university to provide the same athletic opportunities for women as it does for men
- Earned her Law Degree from Northeastern University where she was nationally recognized in 1997 as “Law Student of the Year.” Received a Master of Laws from Georgetown
- Clerked at the Massachusetts Appeals Court
- Served as a state and federal prosecutor, handling cases involving gun and drug trafficking, the sexual abuse of children, gang violence, white collar fraud, public corruption, and civil rights violations
- Worked as an attorney at the National Labor Relations Board in Boston, fighting for workers’ rights and prosecuting employers who exploit undocumented immigrants
- Has experience in private practice where she provided legal assistance to the poor and sued the Police Department for civil rights violations
- The only candidate with significant management experience, she was General Counsel at Massport and the MBTA, managing a staff of over 150, including teams of lawyers

A PROGRESSIVE AGENDA FOR CRIMINAL JUSTICE REFORM

■ JUSTICE FOR CRIME VICTIMS

Rachael Rollins fights on behalf of victims. She will build trust and promote community safety by improving the relationships between law enforcement and residents in neighborhoods impacted by crime.

■ TREATMENT, NOT MASS INCARCERATION

Incarceration is not a solution to addiction and mental illness. We need to focus on expanding access to drug treatment and mental health services.

■ END MANDATORY MINIMUM SENTENCES

Rollins opposes mandatory minimum sentences because judges should be able to determine the sentences of offenders.

■ ABOLISH THE CASH BAIL SYSTEM

She will fight to end cash bail for nonviolent offenses because the poor should not be forced to sit in jail until trial while people with money are allowed to pay their way out.

■ STOP POLICE MISCONDUCT

She has zero tolerance for the use of excessive force, racial profiling, and other practices that target the most vulnerable and destroy trust in the police who serve with honor.
